


- INTRO -

Petramundi's policy requires that the wages of its employees depend solely on the level of skill and dedication they put into the work and is never influenced by gender. Also, Petramundi is a child friendly environment where our employees can bring their kids in moment of need.

Petramundi is experiencing strong company growth, doubling in recent semesters the number of its employees. The company is working to control this growth in terms of sustainability and inclusivity. Petramundi's policies in this regard are leading to more inclusive recruitment, including disabled workers and the promotion of a multicultural environment. Petramundi prohibits the use of child labour at every step of the supply chain, strictly evaluating and auditing its commercial partners and suppliers.

Build resilient infrastructure, promote inclusive and sustainable industrialization and foster innovation

Employment in the manufacturing sector is most likely to be adversely affected by the crisis. Moreover, because of the conservative behavior of older generations, who kept their experience to themselves the goldsmith art of Valenza will be estinguisged. Manufacturing arts like gem cutting and setting or specific goldsmith techniques are now an "endangered know how". Responding to the inefficiency of the allocation of human resources on the Italian labour market Petramundi has engaged with various associations to help the jewelry industry grow and become more attractive to the young generations.

Take urgent action to combat climate change and its impacts

Petramundi will cancel its carbon footprint. Our climate change policy aims to achieve a carbon footprint of less than zero within the next five years. Petramundi's new factory is currently under construction: a historic building subject to a restoration plan that makes renewable energy the first pillar. At the same time, our commitment to climate action is reflected in sustainable consumption and production.

Promote peaceful and inclusive societies for sustainable development, provide access to justice for all and build effective, accountable and inclusive institutions at all levels

Every day 100 civilians are killed in armed conflicts. As a gemstone industry, Petramundi is likely to have an impact by buying from suppliers who directly or indirectly finance non-governmental armed organizations. To manage this risk, petramundi will never have commercial relations with companies or buy assets from Conflict Affected High Risk Areas. Every supplier will be checked and legally checked in accordance with the KYC procedure. Furthermore, every supplier will sign and comply with the petramundi code of conduct.
